South Fork of the Flathead River Trip – Pack-In / Float-Out Reservation Form

1. All South Fork trips include airport pick up, transportation to the trail head, all horse related equipment, camping lodging during the trip, guides, meals, river use fees and flies. State fishing licenses, extra vehicle shuttle costs, outgoing nights lodging and any other transportation costs are not included.

2. A 50% non-refundable deposit is required to secure your dates. FINAL PAYMENT IS DUE JUNE 1, 2018. Unfortunately, due to the extremely difficult logistical nature of this trip, this is a cut and dry policy. Under no circumstance will payments be refunded or rolled over to a future trip if you cancel your trip. Please read the information about travel insurance below.

3. The first step in planning your trip is to take a serious look at whether travel insurance is something you might want to consider. An experienced angler knows that the best-planned trip can be impacted by the unexpected, that's why we recommend Sportsman's Travel Insurance to protect your financial investment.
